

Privacy Policy

Montalbanotechnology.com ("Montalbanotechnology.com") operates montalbanotechnology.com and may operate other websites. It is Montalbanotechnology.com policy to respect your privacy regarding any information we may collect while operating our websites.

Website Visitors

Like most website operators, Montalbanotechnology.com collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Montalbanotechnology.com purpose in collecting non-personally identifying information is to better understand how Montalbanotechnology.com visitors use its website. From time to time, Montalbanotechnology.com may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Montalbanotechnology.com also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on montalbanotechnology.com blogs/sites.

Montalbanotechnology.com only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter

IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

Gathering of Personally-Identifying Information

Certain visitors to Montalbanotechnology.com websites choose to interact with Montalbanotechnology.com in ways that require Montalbanotechnology.com to gather personally-identifying information. The amount and type of information that Montalbanotechnology.com gathers depends on the nature of the interaction. For example, we ask visitors who sign up at montalbanotechnology.com to provide a username and email address. Those who engage in transactions with Montalbanotechnology.com are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. Aggregated Statistics

Montalbanotechnology.com may collect statistics about the behavior of visitors to its websites. Montalbanotechnology.com may display this information publicly or provide it to others. However, Montalbanotechnology.com does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Montalbanotechnology.com discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Montalbanotechnology.com behalf or to provide services available at Montalbanotechnology.com websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Montalbanotechnology.com websites, you consent to the transfer of such information to them. Montalbanotechnology.com will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Cookies
